I am happy to report to you that NYFS has made some significant changes - and that we have achieved significant results. Many of these changes began in July 2012, when the White Bear Lake Area Community Counseling Center merged with NYFS. This move enhanced our relationship with the White Bear Lake School District, strengthened ties with law enforcement in the east metro and increased client visits to our White Bear Area office by over 100%. It even prompted us to change our name to Northeast Youth & Family Services to reflect our expanded service area. We have also realigned our Youth Development programs to put more resources behind our after-school programs which work to close the achievement gap. With all these changes, we also decided it was also time to update our mission statement to better reflect our approach to serving others: Transforming lives today - creating a better tomorrow for youth, families and our community. It has been a busy time for us, but a productive one and we are excited to see how these

### A lifeline to 4,500 youth and families every year

Mental Health Programs: Mental health is as important as physical health for youth and families to succeed at home, at work, at school and in the community. We offer effective, culturally-sensitive individual and group counseling to people of all ages and abilities. Low-income clients are eligible to receive services on a sliding-fee scale to ensure that those who need our help can receive it. Our licensed therapists also work with local school districts and staff to support youth in both their school and home environments.

91% of clients who use NYFS' mental health services report an improvement in their functioning

Northeast Therapeutic Services (NETS): Our day treatment programs serve youth who are struggling with mental health issues. Youth age 14 to 18 receive academic instruction in addition to mental health support and counseling services during the school day. Youth in fifth through eighth grade receive academic support and counseling after school. Our immediate goal is to maximize healthy choices and support behaviors that minimize mental health symptoms. Our long-term objective is to promote lasting changes that are good for the child, the family, the school and the community.

81% of NETS youth are able to return to their home school districts within 10-24 months of service

Youth Development Programs: Our youth development programs focus on three core areas of achievement that are critical to long-term success: academic achievement, employability and citizenship/real-world life skills. We also connect youth with mentors in the community who help them set and achieve goals, raise their expectations of themselves and take steps that will lead them to a better, more successful future than they had previously imagined.

71 youth entered the workforce through our Senior Chore Program and 96% of seniors served by our youth reported that this program helps them live independently in their own homes
